(1) Projected enrollment for San Diego and Sacramento Counties were calculated assuming that 2024 contracting MCPs would maintain their 2022 membership and that the two intended awardees resulting from the MCP procurement would each gain 50% of the membership of exiting MCPs.

(2) Beneficiaries in San Benito who are in fee-for-services Medi-Cal will be enrolled in the managed care plan in the county, California Central Alliance for Health, in 2024. This would increase the total in 2024 by about 20,500.

Projected 2024 Enrollment: simplifying assumptions for calculation purposes

1) No changes in Medi-Cal enrollment from 2022 to 2024. We assumed stable enrollment for the purposes of calculation. However, we know that there will be changes in Medi-Cal eligibility and enrollment given the expansion of Medi-Cal eligibility for individuals regardless of immigration status and the pending end of the COVID-19 Public Health Emergency which will trigger eligibility redetermination statewide.

2) 2022 MCPs that remain in the County for 2024 will retain their membership. If an incumbent MCP is an intended awardee for the Commercial MCP procurement or remains as an MCP in the County resulting from a County Plan Model change, we assume the MCP will retain their membership.

3) 2024 Projections do not take into account enrollment based on member choice. In all counties where more than one MCP operates, members can choose which MCP they would like to be enrolled. For the purposes of calculation, projections do not take into account member selections.
